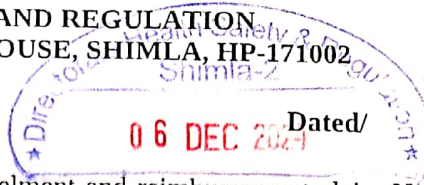

The empanelment is subject to the following conditions: -

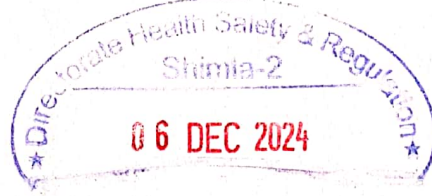
1. The issues related to empanelment and reimbursement claim shall be governed under the policy notified in this regard by the Govt. of Himachal Pradesh vide Notification No. HFW-B(F)1-1/2008 dated June 21 , 2008 and instructions issued hereunder from time to time.
2. These orders shall remain in force for a period of two years, subject to the fulfillment of terms and conditions by the institution concerned.
3. During the empanelment period the inspection team constituted for the purpose will visit the empaneled institutions and if the institution is not found to have services as per the parameters fixed by the Govt. of H.P. the empanelment shall be withdrawn.
4. That there is no dispute, litigation and controversy pending in any Court or office as regard the said hospital, which could jeopardize or adversely affect the interest of the patients care at large and the medical reimbursement process. In case the discrepancy is found at any point of time it would lead to cancellation of empanelment without further notice/reason.

5. The agreement will be treated as cancelled automatically if:

i) Non Production of No Objection Certificate from Pollution certificate beyond 31/03/2026.

In addition to above the relaxation in Single Window Empanelment Policy 2021 continues in favor of M/s Tenzin Hospital Panthaghati, Shimla -171009 as intimated by Chief Executive Officer, RSBY vide letter No.HFW-H-(HPSBYS)SEW/2021 dated 19/11/2024.
